For one session a student will pay \$3700 which includes application fee, express mail fee activity fee, medical insurance and tuition for an eight week period. If you begin at Foundation (level 1), you would study 6 sessions in order to complete the IEC program. The estimated total cost would be \$19,230 (23). Cost of textbook is \$75 - \$125 per session. (6)

All classes at IEC are held at 2151 Salvio St., Suites 210 & 299, Concord, CA 94520. This enrollment agreement covers the period of January, 2 through December 17, 2018. The exact dates of a student's period of enrollment are indicated by the specific session dates listed on page 2 of the Enrollment Agreement. A student will receive a Certificate of Completion upon successful completion of Advanced B. Students may receive a Certificate of Participation upon completion of a session.

A) Payment Information

- A1. Upon receiving the application, we will **only charge the Application processing \$100 fee**. An additional \$50 fee will be added to all applications mailed internationally. Credit card numbers are not kept on file.
- A2. Tuition must be paid by the end of the 1st week of class. Students may pay school tuition and fees in advance once they have received their visa. Please send a request for advanced payment to iec@dvc.edu. There is a \$75 late fee for payment after the 1st week of class.
- A3. International Education Center accepts payment by credit card, debit card, check, money order, or cash. A wire transfer is also accepted for a \$20 fee. Please contact us at iec@dvc.edu for wire transfer information.
- A4. Refund requests made by new students must be made by the first day of class of a session in person or in writing or the 7th day after enrollment, whichever is later. Application fee is non-refundable.

B) Conditional Admission to Diablo Valley College (DVC)

- B1. If you would like to receive a conditional admission letter to DVC, please submit a completed DVC application along with your IEC application materials. IEC will forward your complete application to Diablo Valley College International Students Admission Services (ISAS).
- B2. Only one bank statement is required with a minimum amount of \$22,392
